Closed Session Notes From Agenda	Executive Session held prior to Open Meeting Meeting was called to order. The Pledge of Allegiance occurred. President Donahue asked meeting attendees to wear masks per rules of the Crouse Center. It was stated that if attendees did not mask, the Board would move to recess. A motion and second were advanced and motion to recess passed 7-0. At approximately the 22:30 mark, the meeting was restarted with all Board members present but when attendees refused to mask an unanimous motion to recess for the second time was approved. At approximately the 45:25 mark, the Board recovered again with a 7-0 motion. The President asked the attendees to wear a mask so the meeting could commence, otherwise the meeting would be adjourned. Upon seeing no movement to comply, the Board advanced a motion and second to adjourn for the evening. Motion passed 7-0.
