This is a fund that allows the school district to manage unforeseen expenditure demands and revenue shortfalls; it should be 10-20% of annual expenses. Policy states what steps must be taken if the fund falls below or above the expected balance.

<u>Presentation</u> by Michael Frances explains in more detail. Current fund balance exceeds policy. The recommendation is to bring the fund balance in line with policy. How should extra funds be spent? Two options are taxpayer relief or non-recurring expenses. Comment from Charles Cush to prioritize taxpayer relief. Kristen Fitzgerald raised concern for staffing funding for Early Childhood. Superintendent Bridges cautioned that the board must follow restrictions as to how funding can be spent.
