Matters from the Public

Board Secretary Bridget Tuft read a comment from former Park Commissioner Mike Riley. He asked that the board formally acknowledge the outstanding service of two of the Naperville Park District police who worked with other organizations to make Operation Disrupt a reality. He noted how much this service is needed in these pandemic times. Executive Director Brad Wilson explained that Operation Disrupt is a new collaborative program to address the growing epidemic of teen and young adult suicide. The program uses data to locate areas where suicides have occured and isolated areas where suicides may occur and directs police to these locations. Training is now occurring to learn what to do in the moment. In addition signs now being installed include the national suicide phone number and textline. President Marie Todd said that formal recognition is something the board might want to consider.
