A. Technology Services Update (District Goal 1) - RM

Rodney Mack gave a presentation on cyber security for IPSD. Information shared included statistics that show that education is the leading sector for hacking and the least prepared for cyber attacks. Remote learning and the influx of putting additional information online caught the attention of hackers. He reviewed, at a very high level, the layers of security in use for IPSD 204. Some interesting takeaways- IPSD has not been targeted for ransomware and has not had to file a cyber security insurance claim. The district is moving to two factor authentication and will purchase a new product from CrowdStrike that will not cost the district extra due to being able to reduce existing costs by negotiating current contracts and having the new product serving multiple needs. IPSD intentionally sends out phishing emails to staff as a learning tool. For those who open email, click on links, etc, the technology group can personally follow up to help teach about how to tell if an email is real or an imposter. The majority of cyber attacks can be traced to one person so this type of training is important. Also, false LinkedIn emails are rampant right now so all people should be careful about their interactions on LinkedIn with unknown people. In addition to products, IPSD 204 uses a free program from the Department of Homeland Security that scans their system on a regular basis and gives a resulting report of any deficiencies. They also work in collaboration with fellow districts to learn what is occurring in the education space. Board Members wanted to get additional information about how IPSD 204 compares to peer school districts and many board members stressed that cyber security was one area not to financially cut corners given the need to protect student/personnel information and be able to functionally run school- which is now dependent on the use of computers and applications.
