Concerns over change from bussing to walking status highlighting safety concerns for children crossing Montgomery Road.

Dr Talley noted the following: the passing of a Still Middle School student (moment of silence held and sympathies extended), Over 11% of new hires this year are graduates of IPSD- a proud statistic, 2nd week of STEM camp wrapped up and once again deemed a successful program with sights already on next summer, Summer Boost program also wrapped and deemed a success, over \$10 million in capital construction projects have been finished or nearly finished this summer, district in need of Teaching Assistants- both PT and FT available.

A. Approval of Substitute Pay Increase [Board Policy 5:220 - Substitute Teachers and Board Policy 5:30 - Hiring Process and Criteria] - LL

Business Transacted

Dr Lee gave a presentation on the need for a pay increase for substitute teachers. Rate would increase from \$100 to \$115 per day. This is the first raise in a few years and places IPSD in a competitive position in a tight substitute teacher market. Motion Demming, second Grover. Motion passed with 5 ayes, 0 nays, and 2 abstentions. Two absentions were Fosdick and Donahue as they serve as substitute teachers in IP204.

8. Discussion

A. Fall Plans 2022 -2023 - DE

Deputy Superintendent Eccarius gave a presentation on Covid monitoring and strategies as school opening date nears. Per law, the school district must review this topic at least twice yearly. District is moving away from contact tracing to infection control. Contract tracing has been discontinued. Masks are still encouraged in school. Positive and probable cases will be tracked on the Covid dashboard. If a student is positive or probable positive, they should determine day zero (symptoms appear) and then isolate for 5 days. Students may return to school on day 6 and mask through day 10. If unable or unwilling to mask days 6-10, they must isolate for 10 days. If symptomatic and unwilling or unable to test, students should isolate for 10 days. Symptoms defined by a CDC reference. If a student is symptomatic and receives a dr note, they may return to school once symptoms cease. Example given- student is symptomatic, student goes to dr and a diagnosis of strep is given. Once the student is on antibiotics and fever free they can return to class. Dr Talley was clear that there will be lots of scenarios so parents should rely on the school nurse who will walk them through the flow chart. Board Member Karubas asked about ventilation improvements in schools which Dr Talley responded with details on improvements/current conditions which meet or exceed standards. Board Member Karubas asked that the Board be kept abreast of testing as the school year commences. Karubas also asked about the continued wording about mask mandates in the parent handbook. Dr Talley responded that while it is hoped that conditions will not reoccur to warrant mask mandates, they felt it prudent to keep language in should those conditions occur.

B. Legislative Advocacy Update - LD

Board Members Rising and Grover have presented two amendments to a IASB panel for consideration by the voting members of IASB at the IASB gathering this Fall. Amendments 11 and 12 were advanced by the IPSD Board. Amendment 11 proposed nonpartisan language. The panel has attached a DO ADOPT stance to this amendment. Amendment 12, which changed wording from legislative candidates to legislative positions, received a DO NOT ADOPT stance. IPSD can appeal this decision. Amendments will be voted on at the IASB gathering in the Fall. Board Member Grover will represent IPSD as its voting member.
